As you know, I have asked the State Corporation Commission to reject the application by TRIP II, the conglomerate that owns the Dulles Greenway, to raise tolls on the Dulles Greenway.

Today I sent another letter (enclosed) to the SCC asking for a public hearing on the proposed toll increase. I believe it is incumbent upon the SCC to hear from the public about the impact of such a toll increase, which could make the Greenway one of the most expensive toll roads in the country.

Dear Mr. Peck:

I have just learned that to ensure public discussion in case number PUE-2006-0081 regarding the request by Toll Road Investors Partnership II, L.P. (TRIP II) to increase tolls on the Dulles Greenway, a public hearing must be requested. I write today to request such a public hearing on the proposed Dulles Greenway toll increase submitted to the Virginia State Corporation Commission (SCC) in follow-up to the letter I submitted yesterday urging the SCC to reject TRIP II's request (copy enclosed).

As I stated in my September 5 letter, should the SCC approve TRIP II's request, the Dulles Greenway will become one of the most expensive toll roads in the country. For a matter so important to working families in northern Virginia, I believe it is incumbent upon the SCC to hear from the public about the impact of such a toll increase.
